Curricular Innovations

Redesigned Course for Online Instruction–Spring 2023

Redesigned PLSI 318-Modern Citizenship as a once weekly synchronous lecture and discussion to explore the ways in which people today engage with the political world. The goal of this class is to understand how technology and culture have changed the way that people learn about and engage in politics. By redesigning this class into an online format, I was able to better integrate technology, one of the very forces that has reshaped political engagement, into the class itself.

Completed the Teaching New & Newly Returning Students course during Summer/Fall 2021

This course focused on a variety pedagogical topics relating to supporting student success on the return to campus following the period of online learning brought about due to the COVID-19 crisis. Topics include advising and academic study skills, strategies for teaching reading and writing, and critical digital and information literacies.

Completed the CEETL Video for Online Learning and Teaching Micro Course during Summer 2021

This course focused on the pedagogical theory behind effective instructional videos and an introduction to the various methods of video creation and editing with the goal of improved delivery of online and hybrid learning.

Redesigned Courses for Online Instruction–Fall 2020

Designed PLSI 303-Fundamentals of Political Science as a once weekly synchronous lecture and seminar combination, so as to offer fundamental information about research methods, while still allowing students the chance to practice skills and build community in an online environment. Additionally, I organized and facilitated online panels of department faculty to introduce students to the discipline.

Designed PLSI 476-The American Presidency as a hybrid asynchronous and synchronous class. Every week students had a recorded lecture highlighting the key ideas and questions for the week along with readings. Additionally, the class met synchronously on Thursdays for a seminar discussion in which students lead a seminar discussion of topics relating to the presidency.

In an effort to best serve our students during the Corona virus Pandemic, I prioritized developing my skills in online pedagogy.

Constructed new course that explores the ways in which people today engage with the political world. The goal of this class is to understand how it is that technology and culture have changed the way that people learn about and engage in politics; to create a new understanding of what it means to be a "modern citizen."

Created new course-PLSI 460: Topics in American Politics: Choosing a U.S. President.

Constructed new course that examines the presidential election process from primaries and caucuses through to election day, with a special focus on connecting political science research on campaigns and elections to the current electoral process. This class is designed to be offered in the Spring semester of a presidential election cycle as the primaries are occurring.

Created new course–PLSI 479: The United States Congress.

Constructed new course that focuses on the role of Congress in American Politics. Students learn about the electoral incentives of the members, the structure of the legislative process, and the ways in which the institution fit in to the broader American political system.

Constructed new course that focuses on the institution of the presidency in American Politics. Students learn about the history and powers of institution, how it fits into the larger American political system, and the role the president plays in the policy-making process.
