PLSI 303-01: Fundamentals of Political Science Fall 2023

Course Description: Welcome to PLSI 303, Fundamentals of Political Science! This course introduces the SFSU Department of Political Science, and to the discipline and practice of political science for majors. Students will be introduced to the department (faculty, requirements, opportunities), to the different subfields of political science, and explore how political scientists design their research in an attempt to answer significant questions within politics. The course will also provide an overview of principal methodological approaches, introduction to research design, and principles of social scientific inquiry to better prepare students for other courses in the major, especially PLSI 304 Scientific Inquiry in Political Science. This course is designed to give students the foundational skills and knowledge to successfully complete a degree in the Department of Political Science.

Student Learning Outcomes:

- 1) Introduces an overview of the PLSI Dept (faculty, subfields, opportunities)
- 2) Identify key characteristics of the discipline of political science, the main intellectual and methodological approaches, and how political science compares to and differs from other social sciences.
- 3) Identify different subfields of political science and demonstrate an understanding of the main objectives and methods of each subfield.
- 4) Gain understanding and mastery of basic principles of social science inquiry and a social scientific approach to the study of politics.
- 5) Demonstrate familiarity with the principles of research design in political science.

Required Materials:

Readings will be posted on the class Canvas page, which I expect students to be checking multiple times a week. There are no textbooks to purchase.

Note: If ever a student can't access a reading via a web link, it is the responsibility of the student to contact me to let me know about the issue. Not being able to access a reading is not an acceptable reason for not having completed the reading.

COVID/ Wildfire Contingency Plan

In the event that campus closes (whether for one week or for the remainder of the semester) because of COVID or wildfires, the affected class sessions will still meet via Zoom. I plan to email and upload to Canvas a Zoom link as soon as I am aware of a campus closure, but it is your responsibility to check email/the Canvas class page. During those online classes, if/when they happen, I kindly ask that you find a relatively quiet space, mute yourself when you are not speaking and have your cameras on.

This will also be the plan if at any point during the semester I should contract COVID, as I would not be able to come to campus. My fingers are crossed that we won't need any of this, but it's better to be prepared!

Drops, withdrawals and WU grades

Students may drop a class during the first two weeks. Students are encouraged to drop before the end of the second week if they don't want the class and no longer plan to attend. Dropping the class is the responsibility of the student! However, I reserve the right of dropping you from the course if: (1) you fail to log in within 3 days after the start of the semester; (2) you fail to log in for more than one week during the session; (3) if you fail to turn in less than half the assigned work or exams.

Students who do not drop and no longer attend may receive a WU grade (withdrawal-unauthorized). Please be aware that a WU grade is counted as an F for GPA purposes. After the second week, you can withdraw from a class only if you have **serious and compelling reasons with current**, **relevant supporting documentation**. The following are examples of **non-serious and non-compelling reasons** and would be denied:

- Changing major
- Poor academic performance in class
- Course no longer needed
- Missing pre-requisite(s)
- Instructor forgot to drop
- More time needed for other classes

Unexpected changes in work schedule or serious accident, protracted illness, or family emergencies may be considered serious and compelling if appropriate supporting documentation is attached. The petition must be submitted within a reasonable timeframe (e.g., within 2 weeks of illness or change in work hours) and must include your unofficial transcripts. In the last two weeks of the semester, you may not withdraw from a class or the University, except only in the case of a **documented** serious illness or verified accident.

Withdrawals cannot be initiated electronically and must be submitted using a paper application. A maximum of 18 units can be withdrawn, and a course can only be repeated once with a failing grade.

In-class Discussion

Occasionally, there will be in class discussions related to political issues and current events related to the course material. I expect and want to hear a range of opinions from the students in the class. Common kindness and courtesy are expected from all participants and all opinions will be treated with respect. My role is to ask follow-up questions and solicit counterarguments related to the topic at hand; it is not my intention to sway your views and I encourage the respectful exchange of all ideas.

Late Work Policy

Be sure to pay close attention to deadlines—there are many deadlines and while there will be reminders, completing the work is your responsibility. Every student gets one late quiz or assignment that will be accepted without documentation of a serious or compelling reason. To use that, students must email me (reissler@sfsu) as soon as you realize you missed the assignment deadline. Late work that is accepted is subject to a 10% penalty. Exams are not eligible for this policy.

Makeup Exams

Makeup exams will only be given in the case of medical reasons or in extraordinary circumstances. Students must notify me <u>in advance of the close of the exam</u> to schedule such a makeup. The format of the makeup exam is at my discretion, so as to preserve academic integrity. Additionally, written documentation of the medical reason or extraordinary circumstance will be required, and students should expect the documentation to be verified. Additionally, makeup exams may be subject the late work penalty policy.

Students are encouraged to attend my office hours to discuss course material and assignments. This is an opportunity to get better, more in-depth answers to any concerns. I am happy to schedule appointments during university business hours, should there be conflicts with my standard weekly office hours. Additionally, I welcome you to come to my office hours to meet with me for major advising or any other concerns.

Plagiarism Policy

Plagiarism includes using someone else's exact words, or even their ideas but not their exact words, without proper citation. It is a good rule of thumb that if you did not know the information before you started the assignment, you must cite your source.
